G.S.R.20 .-In exercise of the powers conferred by section 15 of the Mines and Minerals (Development and Regulation) Act, 1957 (Central Act No. 67 of 1957), the State Government hereby makes the following rules further to amend the Rajasthan Minor Mineral Concession Rules, 2017, namely:-

1.Short title and commencement.- (1) These rules may be called the Rajasthan Minor Mineral Concession (Amendment) Rules, 2026.

(2) They shall come into force from the date of their publication in the Official Gazette.

2. Amendment of rule 2.- In clause (iv) of sub-rule (1) of rule 2 of the Rajasthan Minor Mineral Concession Rule, 2017, hereinafter referred to as the said rules, for the existing expression "Revenue Intelligence Officer of State Directorate of Revenue Intelligence (SDRI)", the expression "Officer of Directorate of Revenue Intelligence and Economic Offences not below the rank of Deputy Director and Revenue Intelligence Officer" shall be substituted.

3. Amendment of rule 54.- In sub-rule (4) of rule 54 of the said rules, for the existing expression "Revenue Intelligence Officer of State Directorate of Revenue Intelligence (SDRI)", the expression "Officer of Directorate of Revenue Intelligence and Economic Offences not below the rank of Deputy Director and Revenue Intelligence Officer" shall be substituted.

4. Amendment of rule 60.- In sub-rule (2) of rule 60 of the said rules after the existing expression "Assistant Mining Engineer (vigilance)," and before the existing expression "Mines Foreman", the expression "Officer of Directorate of Revenue Intelligence and

Economic Offences not below the rank of Deputy Director and Revenue Intelligence Officer" shall be inserted.

5. **Amendment of rule 61.-** In sub-rule (1) of rule 61 of the said rules, for the existing expression "Revenue Intelligence Officer of State Directorate of Revenue Intelligence", the expression "Officer of Directorate of Revenue Intelligence and Economic Offences not below the rank Deputy Director and Revenue Intelligence Officer" shall be substituted.
